Report of the Legal Department of IBSSA for the year 2001

Dear President, dear friends and IBSSA members,

first of all I would like to express my deepest gratitude for appointing me Chairman of Legal Department of IBSSA. This is a great honour for me to supervise in the Department.

In my first official report I inform you about the planned activities and goals of the department:

- 1. It is necessary to strengthen the Legal Department by the staff and rules of the department.
- 2. Who will agree in each country will be certificated for conducting legal work.
- 3. Make the standard of the programs in PC in all office.
- 4. Accredit office or bureau.
- 5. To create system of a video of a conference. (For economy and operative work).
- 6. To create IP-voice or phone a PC office system.
- 7. On the basis of the laws of the EU to create IBSSA Arbitrage.
- 8. Make course education the lawyers for arbitration from each country.
- 9. To make IBSSA HQ the Internet communication and connection with national or accredited IBSSA office servers.
- 10. To make audit of the certificated IBSSA members, IBSSA bureau, IBSSA instructors and to all publish.
- 11. To create fund the social and labour help for IBSSA members. (If a trauma or pension etc.).
- 12. To issue the labour sanction for work in other countries and to make under the contract an exchange to the members in other countries. (For better international of experience bodyguards, experts, instructors, and lawyers).
- 13. To create national and international rates not only for the experts but also for all who wants to do protection itself and family.
- 14. Each member should answer for the recommendation for the friend of the member (then it is possible to ask that everyone did for IBSSA each year not only the payment paid of the member.
- 15. To create or to help national sports federation which does selection potential IBSSA of the staff and members.
