The open meeting was held several times between 16 - 21 September 2007 in Budapest / Hungary.

4. The Board meeting adopted the final Congress agenda and program. (Both can be found at www.ibssa.org)

- 5. During the meeting the decision of the last Congress was also underlined, which stated: not active and not working officials will be replaced during the forthcoming IBSSA Congress, so all Regional Representatives, Country Representatives, Coordinators and leaders of Departments must be present and report during the event!
- 6. The President reported that on the 14th September the appointed international Auditors of IBSSA were checking the financial situation, documents and books of 2004, 2005 and 2006. They did find everything correct and in order.

During this audit it was agreed that all documents would be published to the members. (Audit Report, Balance Sheets, Budgets)

- 7. In spite of the information issued months ago several proposals for decorations at the Congress were not sent in time, so the Board of Directors decided to postpone the deadline till 15th October 2007!
- 8. Due to the non-active work of some Vice Presidents of the Executive Committee, the Board of Directors proposed to prolong the term of duty of Mr. Constantin BUZATU as Chairman of the Executive Committee until the last day of the 13th Congress (2008).

It was also decided that new Vice Presidents of the EC must be appointed during the forthcoming Congress in Belgrade!

- 9. Dr. Rony KLUGER President of IBSSA ISF and Dr. Frank PHILIPOOM General Secretary of ISF gave thorough information about their plans concerning the development of the **International Sport Federation**.
- 10. President Prof. George POPPER informed all participants that IBSSA became full member of the **IFNGO** (International Federation of Non-Governmental Organisations), which organisation represents IBSSA in the UN and in different UN Organisations through its consultative status.
- 11. The IBSSA President also informed everyone that following the cooperation with INEOA (International Narcotic Enforcement Officers Association), with active IBSSA presence the **"European Drug Enforcement and Drug Prevention Association"** was established and registered in Hungary.
