

**XXI. Annual Congress of the IBSSA  
and  
6<sup>th</sup> “Partnership for Security” International Joint Conference**

**21<sup>st</sup> March 2018  
Tel Aviv, ISRAEL**

Dear IBSSA Members,

hereby we inform you that the **XXI. Annual Congress and General Assembly of IBSSA** will be held on the **21<sup>st</sup> March 2018 in Tel Aviv, Israel.**

We highly recommend the participation and expect our representatives, officials and members from many countries in the event, since next year there will be elections of the new leadership and new appointments.

According to the Statutes of IBSSA a new Board of Directors is elected every five years. The nominations will be closed one month before the date of the Congress (*on the 21<sup>st</sup> February 2018*). Based on the nominations received by the deadline, the IBSSA Executive Committee will present to the Congress participants the proposal for the new leadership. The General Assembly only decides on the members of the Board of Directors and the Auditing Committee, for other positions – on the basis of the received proposals – the elected new leadership will appoint the Country Representatives, as well as the chairmen of different departments and committees.

The Directive has not changed: only those officials are renewed, who did a valuable job during the given period.

For many years, our organization has given great importance to partnership and cooperation between authorities, law enforcement agencies and the private sector in the fields of security and crime prevention throughout the world. Therefore, as part of the official IBSSA event, we are also organizing the **6<sup>th</sup> “Partnership for Security” International Joint Conference of IBSSA – IPA** (*International Police Association*) – **IAPA** (*International Auxiliary Police Association*).

This initiative now has a strong international reputation, redeemed its hopes, and in recent years, numerous international and national organisations have joined the founding 3 organisations, such as the Europolice Federation, FEMERAID International, Knightly Orders, Universities, National Guards, Sport organisations, etc.

The main topics of the International Conference –which are a huge challenge in almost every country in the world:

- Fight against international terrorism
- Fight against drugs
- Fight against human-trafficking and modern slavery

In practice, we are experiencing the close interplay between these three priority areas, so our main task will be to develop, further develop and standardize the related education and training methods.

It is a tradition that after the IBSSA Congress and the International Conference will take place the official **Award Ceremony** of the participating organizations.

The official language of the Congress and the International Conference is English, and the requests for speeches should be announced by 21<sup>st</sup> February 2018 to the IBSSA Headquarters.

**The two mandatory travel documents for anyone travelling to Israel are:**

- **Passport** - Your passport must be valid for at least 6 months from the date of your arrival in Israel. If it's not, make sure to renew your passport before traveling to Israel.
- **Departure Ticket** - You must also have a valid departure ticket out of the country within 3 months.

**VISA ISRAEL REQUIREMENTS BY COUNTRY**

If you are a citizen of the following countries and do not plan on staying more than 3 months, then you do **NOT** need a visa for Israel. This list was last updated on April 2017.
