My name is Thomas O. Szabo, I am a Batchelor of Economics from Fribourg University, Switzerland, and an Australian Public Accountant and Company Auditor registered under number 5898 in accordance with the provisions of the Companies Act of the State of New South Wales, Australia, since 1966.

I have been working with the Sydney Office of Price Waterhouse as National Office

Accountant, up to 1990, and in that year I requested and was granted a transfer to the then
newly established Price Waterhouse Office in Budapest, Hungary, as head of its Finance

Department.

I have left this firm in 1994 to become a shareholder and Managing Director of an Australian/Hungarian Accounting and Auditing joint venture called Four-Go Ltd.

I have audited the accompanying Balance Sheet and Profit and Loss Statement of the International Bodyguard&Security Services Association as at December 31, 2001, reviewing various accounting documents, related statements of operation and Bank Statements. It is, again, my duty to draw attention to the fact that a large number of members failed to pay their memberhip dues to the Association.

I must point out that the following losses have been incurred since 1997, including those of this year:

a total so far of USD 121.062,-.

It is not possible to exist, as you no doubt realise, with these losses, year after year, otherwise your Association will come to an abrupt end. This nobody wishes to "achieve" I am sure.

I have made you aware of this sorry state of affairs in my last Audit Reports but it seems to me that despite your Treasurer's valiant efforts to keep the Association going and finishing the year with a small profit, the increasing amount of losses indicates a total lack of cooperation in the respect.
